Dr. Mart will assist attorneys in making sense of expert mental health professionals' reports by becoming knowledgeable consumers of psychological/psychiatric assessments. Specific topics include: interpreting test scores, basic statistical concepts made easy, signs of confirmatory bias, psychological testing and *Daubert*, and effective cross examination of mental health experts. The presenters will identify solutions for problems, discuss innovative initiatives such as Warmlines and the use of peer specialists, and provide in depth information on Recovery Learning Communities (RLCs) which connect people to peer support, recovery-oriented information, vocational assistance, and referrals to outside services. 2:00 **WHAT'S NEW: LEGISLATIVE AND CASE LAW UPDATES**

This session will explore anticipated questions in changes to guardianship procedures under the new Massachusetts Uniform Probate Code, effective 7/1/09. Attorney Fleischner will discuss how the statute will likely interface with the new caregiver statute, Chapter 201F, and with protective proceedings under the DPPC and elder abuse statutes. Finally, this session will cover implications for mental health litigation in *Kenniston v. DYS* and *Indiana v. Edwards* in addition to developments in *Rosie D.* services and cutbacks in DMH services.

A Juvenile*, and the admissibility of dangerousness opinions and past behavior.
