Welcome to the first edition of what we hope will be a regular newsletter from the social service expert team. In the last 6 months CPCS has grown the private social service expert program to a team of three. **Kristin Dame, LMHC**, is the Director of Private Social Work Services for the Private Counsel/Adult Criminal (PCD) and Mental Health Litigation (MHL) Divisions; **Claudia Dunne**, **LICSW**, is the Director of Social Work for the Youth Advocacy Division (YAD) and manages the private Social Services Expert vendors for that division; and **Meg Grant**, **LICSW**, remains the private Social Work Coordinator for the Children and Family Law Division (CAFL).

A holistic model of legal defense requires the use of social service experts to help clients meet their legal goals.

It is exciting to finally be fully staffed and as a team we are working to update systems in the hopes of better serving the private bar and the social service experts (SSEs) who work together to provide a holistic defense to our clients. To that end we have attached an updated **Vendor Information Questionnaire** that better represents the work that SSEs do for each division. We strongly encourage you to complete this form and return it to us, with an updated resume, at your earliest convenience.

Getting Started on a Case

What you need when starting a case:

- An APPROVED motion for funds.
- The NAC #
- Letter of Engagement that specifies scope of requested work and services, and your role.
- Client contact information.
- Signed releasesremember do not contact anyone without permission from the attorney.
- The context/theory/ criminal charges of the case.
- Timeline for any work product.

Conflicts of Interest

If you work for a state, city, or municipal agency it is your responsibility to complete the required Conflict of Interest check with the State Ethics Commission. If you are required to complete a Conflict of Interest form, please send a copy of the form signed by your agency's Appointing Authority to us. It will then be reviewed by CPCS for a final determination.

Professional Licensing and Certifications

While licensing is not required of CPCS vendors, some attorneys may prefer to retain a licensed SSE. We strongly encourage you to obtain, maintain and/or renew your professional licenses and certifications.

Billing

First, we want to thank you for your patience during the great system crash in March. We know it may have created financial hardships for many of you, and we truly appreciate your tolerance. Please remember to check you VBill system regularly for notifications from the billing department. Here are the contacts for various vendor questions:

- * To follow up on the status of your State Vendor Application or update your information, please contact: vendorinfo@publiccounsel.net. Please allow 3 weeks from submittal before checking on the status.
- * For billing inquiries, please contact: vendorbills@publiccounsel.net
- * If you are locked out of VBill, or requesting that a payment be stopped and replaced, please contact: vendorbills@publiccounsel.net
- * For any other questions or assistance with regard to court cost billing, please contact: vendorbills@publiccounsel.net

Finally, don't forget to keep **contemporaneous time logs**, as they must be submitted with the computer generated Vbill form you print, sign and mail in to CPCS. Time is tracked in 10ths of an hour, and the easiest way to calculate this is to take the number of minutes worked and divide it by 60 and round to the 10th of an hour. For example:

If you worked 82 minutes, 82/60=1.3666 would be 1.4 If you worked 30 minutes, 30/60 would be .5 If you worked 6 minutes, 6/60 would be .1
