

2018-2019 School Discipline in Massachusetts' Gateway Cities

Massachusetts' <u>Gateway Cities</u> lack equitable resources and have <u>significantly less funding</u> to spend per pupil than other Massachusetts cities. This analysis of school discipline rates in some of the Commonwealth's Gateway Cities (as well as the city of Boston and statewide discipline rates) looks at how this reality impacts students of color, <u>poor students</u> and students with disabilities.

Discipline percentages are derived from unduplicated counts (that is, students who were discipline multiple times are only counted once). Also please note that this data does not include charter schools and a district highlighted in yellow indicates a double-digit discipline rate for at least one subgroup.

Statewide:

• 41,501 out of 976,789 students were disciplined (4.2%).

By Subgroup:

- 25,979 out of 355,902 students who are <u>economically disadvantaged</u> were disciplined (7.3%).
- 14,657 out of 187,717 students with a disability were disciplined (7.8%).

By Race:

- 17,442 out of 568,870 White students were disciplined (3.0%).
- 7,506 out of 90,716 Black students were disciplined (8.3%).
- 13,725 out of 208,289 Latinx students were disciplined (6.6%).
- 832 out of 69,071 Asian students were disciplined (1.2%).
- 1,832 out of 36,854 Multi-race, Non-Hispanic or Latinx students were disciplined (5.0%).
- 132 out of 2,166 American Indian or Alaskan Native students were disciplined (6.1%).
- 32 out of 823 Native Hawaiian or Pacific Islander students were disciplined (3.9%).

Boston:

By Subgroup:

- Black (9.5%), Latinx (6.6.%), Multi-race (8.4%), and Native Hawaiian (7.7%) students with a disability are at least 2X more likely to be disciplined than White students with a disability (3.1%).
- Black (6.4%), Latinx (4.3%), Multi-race (6.7%), and Native Hawaiian (5.1%) students who are economically disadvantaged are at least 1.5X more likely to be disciplined than White students who are economically disadvantaged (2.8%).

By Race:

- 107 out of 7,835 White students were disciplined (1.4%).
- 978 out of 17,115 Black students were disciplined (5.7%).
- 917 out of 23,279 Latinx students were disciplined (3.9%).
- 31 out of 4777 Asian students were disciplined (0.6%).

- Overall, students with a disability were disproportionately disciplined.
 - o 16.1% of Black students, 15.4% of American Indian students, 13.3% of Latinx students, 11.7% of Multi-race students, and 8.3% of White students with a disability were disciplined.
- 14.8% of Native Hawaiian students, 11.1% of Black students, 9.5% of Multi-race students, 8.1% of Latinx students, and 7.1% of American Indian students without a disability were disciplined while 5.3% of White students without a disability were disciplined.
- 23.1% of Native Hawaiian or Pacific Islander students who are not economically disadvantaged were disciplined.
- 12.7% of Black students and 12.6% of Multi-race students who are economically disadvantaged were disciplined while 8.3% of White students who are economically disadvantaged were disciplined.

- 5.5% of Black students without a disability were disciplined while 1.7% of White students without a disability were disciplined.
- 6.8% of Black students, 6.7% of Latinx, and 5.5% of White students with a disability were disciplined.
- 6.7% of Black students who are economically disadvantaged were disciplined while 2.8% of White students who are economically disadvantaged were disciplined.

• Black (3.2%) and Latinx (2.9%) students who are not economically disadvantaged are at least 2X more likely to be disciplined than White (1.5%) students who are not economically disadvantaged.

- 21.4% of American Indian students, 10.3% of Black students, and 10.1% of Multi-race students who are economically disadvantaged were disciplined while 6.2% of White students who are economically disadvantaged were disciplined.
- 16.7% of American Indian students who are not economically disadvantaged were disciplined.
- Overall, American Indian or Pacific Islander students were disproportionately disciplined.

- Overall, students who are economically disadvantaged were disproportionately disciplined.

o 16.7% of Native Hawaiian students, 13.3% of American Indian students, 12.2% of Black students, 11.1% of Multi-race students, 9.1% of Latinx students and 7.5% of White students who are economically disadvantaged were disciplined.
