Last year in the wake of George Floyd's death, we took the time to look at race and the justice system. In many ways it is easy to look outside of ourselves and see the impact of systemic racism on all aspects of the criminal justice system, but how did the system get so broken? Certainly, when we look back at the history of race in this country, it is not difficult to understand how we got to this point. The film "13<sup>th</sup>" on Netflix provides a good historical account of how being black in America became a criminal offense. In February 2022, Jeffery Robinson's "Who We Are: A Chronical of Race in America" will be released and further examines the history of race in this country. Identifying conscious and explicit bias and racism is easy. It is right there, and we know it when we see it. While new laws and initiatives seek to address the systemic racism in the child welfare and criminal justice systems, change will move slowly if we do not acknowledge and address the implicit biases we all hold. Educating ourselves and those in positions of power is essential to the work.

Kimberly Papillon, JD, a nationally recognized expert in the neuroscience of implicit and unconscious bias, defines implicit bias as operating outside of the person's awareness, and can be in direct contradiction to a person's espoused beliefs and values. What is so dangerous about implicit bias is that it automatically seeps into a person's affect or behavior and is outside of the full awareness of that person. She suggests that implicit bias is much more common than one would think.

# Getting Started on a Case

What you need when starting a case:

- The ENTIRE APPROVED Motion for Funds.
- The NAC #.
- Letter of Engagement that specifies scope of requested work and services, and your role.
- Client contact information.
- Signed releasesremember do not contact anyone without permission from the attorney.
- The context/theory/ criminal charges of the case.
- Timeline for any work product.

### **NUTS and BOLTS**

### **BILLING**

While we can help with some billing questions, your best resource for answers is the Vbill User Manual or you can email <u>vendorbills@publiccounsel.net</u> with any questions. That being said, here are a few quick reminders.

- Travel time is billable. The rate is lower than the hourly rate for other services and is prepopulated by VBill.
- Remember if you make a billable phone call during your travel time, you cannot bill for both services.
- Reminder FY2022 is from 7/1/21-6/30/22
- Billable hours per FY are capped at 1,650, and you can only bill up to 12 hours/day. Anything over those hours requires a waiver.

Bills must now be submitted withing 30 days of the last billable service or they will be reduced, and after 60days they could be rejected. Make sure you are aware of any impending billing deadlines. We want to make sure that everyone is getting paid for the fabulous work they are doing!

# Our Work, Works!

### Feedback from a CAFL private panel attorney

I want to let you know that the social worker did a fantastic job doing a home study for a case of mine, where the mother had moved to another state, and we didn't want to take the time to do an interstate home study. She did the study over zoom; I got authorization for additional funds for her to review the DCF record and follow up with collaterals. The trial was a few weeks ago. DCF at the end agreed that the expert's report/home study could be admitted into evidence, so she did not need to testify. But I have no doubt she would have been an excellent witness. The judge granted mother's Motion for Review and Redetermination and custody was returned to her. This is quite a big step for the judge, because the child has moved out of state as a result of the decision and the court no longer has any follow up jurisdiction. Thank you so much for suggesting that I seek out this social worker.
